| Advanced Education, Employment and Labour | Commission on Improving Work Opportunities for Saskatchewan Residents | The work of this commission was completed over a year ago. The discontinuation of this board is a procedural requirement. |
| Advanced Education, Employment and Labour | Cypress Hills Regional College Board | Prairie West Regional College and Cypress Hills Regional College merged to form the Great Plains College. |
| Advanced Education, Employment and Labour | Government Universities Consultation Committee | Other mechanisms have been put into place to facilitate ongoing discussions between the government and the universities. |
| Advanced Education, Employment and Labour | Prairie West Regional College Board | Prairie West Regional College and Cypress Hills Regional College merged to form the Great Plains College. |
| Advanced Education, Employment and Labour | Training System Committee of Review | The committee presented its findings in November 2005 and has been inactive since that time. |
| Advanced Education, Employment and Labour | Wood Dust Committee Task Team | The task team was established to review the recommendations of the Occupational Health and Safety Council in 2006. The task team has completed its work and thus is no longer required. |
| Agriculture | Agri-Food Innovation Fund | Fund wound-up on March 31, 2009 with the repeal of the Agri-Food Innovation Act. |
| Agriculture | Agri-Food Equity Fund Investment Review Committee | Committee no longer required as the Equity Fund no longer makes investments and the ACS Board oversees the wind-up of previous investments. |
| Agriculture | Beef Industry Advisory Committee | Ministry already consults directly with industry organizations and livestock stakeholders. |

| Agriculture | Producer Advisory Committee | Ministry already consults directly with Livestock Breeder and Feeder Associations and other livestock organizations on the Livestock Loan Guarantee Program. |
| Agriculture | Provincial Patrons Advisory Committee | Ministry already consults directly with farm and livestock organizations on provincial pastures issues. |
| Crown Investments Corporation | Saskatchewan Development Fund Corporation- Board of Directors | Currently in wind down phase of operations. |
| Crown Investments Corporation | Investment Saskatchewan- Board of Directors | De-designated in August as a Treasury Board Crown and will not have an external board. Will be run out of CIC. |
| Corrections, Public Safety and Policing | Power Engineers Advisory Committee | This Committee has been inactive for a number of years. |

| Education | Saskatchewan Literacy Commission Advisory Board | The Ministry integrated the literacy role in 2008, and consultations are undertaken on an as-needed basis. The Board met rarely in 2008-09 due to changes. |
| Education | Education Equity Task Force | The Task force has not been operational since 2004 and was initially established to prepare a map of reconstructed school divisions. |
| Education | Minister's Early Learning and Child Care Advisory Board | The Board is being discontinued as the Ministry uses other mechanisms such as ad hoc consultations for regular and in depth discussions with the early learning sector. |
| Education | Saskatchewan Association of School Business Officials | SASBO has moved from regulated profession to non-profit corporation status in 2008. The appointment of a public representative is no longer required by statute. |
| Education | Strengthening Educational Capacity Forum | The forum concluded in September 2005. Other forums such as the Human Services Integration Forum are now used to consult with Stakeholders. |
| Enterprise Saskatchewan | Circle of Economic Partners Advisory Committee | Committee was determined to be unnecessary by Enterprise. |
| Enterprise Saskatchewan | Saskatchewan Labour Market Commission | Transferred from AEEL and has been rolled into a new program in Enterprise Saskatchewan. |
| Enterprise Saskatchewan | East Central Enterprise Region Stakeholder Group | Stakeholder group was incorporated into the Enterprise Region. |
| Enterprise Saskatchewan | Meadow Lake Enterprise Region Stakeholder Group | Stakeholder group was incorporated into the Enterprise Region. |

| Health | Advisory Committee on Family Planning | It is recommended that this committee be disbanded and the work be done on a contract basis with an non-government organization through the existing third party grant process. |
| Health | Advisory Committee on Institutional Pharmacy Practice | The function of this board will be provided by the new Drug Assessment Advisory Committee. |
| Health | Alcohol and Drug Abuse Advisory Council | A new advisory committee on addiction is being developed by the Ministry. |
| Health | Drug Quality Assessment Committee | The function of this board will be provided by the new Drug Assessment Advisory Committee. |
| Health | Emergency Medical Advisory Committee | This Board no longer meets. |
| Health | Emergency Medical Technician Licensing Appeal Board | Appeals are now handled by the Saskatchewan College of Paramedics. |
| Health | La Ronge Hospital Board | This Board no longer meets. |
| Health | The Provincial Advisory Committee on Older Persons | This Board no longer meets. |
